  - B)** affirm that there is no plagiarism or copying, either partially or entirely, from someone else's designs and/or works and shall comply with the relevant laws and guidelines implemented as well as the Code of Ethics, as stated in the Information Technology Act, 2000 and the subsequent rules.
  - C)** state, submit and affirm that the content published by them on their Application is as per the guidelines provided by the Ministry of Information and Broadcasting, Government of India and display such ratings of the content as may be deemed necessary by the said Ministry.

- c)** The application has or develops security or privacy threat of any kind,
- d)** The app is generating obscene or unlawful content,
- e)** The app contains activities that tend to be violating any law or terms stated under the laws of India.

**4. Privacy Policy**

**6. Indemnity**

**7. Malicious Activities**
